The representation of the issue of bullying can be seen in several films. One of the films that discuss bullying is the film "Joe Bell". Researchers researched the film "Joe Bell" using descriptive qualitative methods with semiotic theory from Roland Barthes in analyzing data based on the classification of types of bullying. The purpose of this research is to know the representation of bullying issues that occur in the movie "Joe Bell". The results of this study are that the film "Joe Bell" represents the issue of bullying through scenes, dialogues, and storylines with an emphasis on types of bullying including verbal bullying, physical bullying, and cyberbullying.

1. Introduction

Bullying is currently a very serious and troubling social phenomenon. Bullying is an action taken by a person or a group of people by hurting the victim in various ways. Bullying has various forms including verbal bullying, physical bullying, and cyberbullying. The act of bullying has been raised into a film, one of which is the film "Joe Bell". The film "Joe Bell" is a film directed by Reinaldo Marcus Green and shown on Netflix it is set in America and is based on a true story, this movie tells a story about a struggling father for the campaign about the danger of bullying. Also in this film signs as well as a description of the issue of bullying.

According to Alex Sobur, the film is a means of conveying messages that can communicate the contents of messages in films to its audience, therefore a good film does more than just provide entertainment but can also be a means of full education of meaning and knowledge of something raised in film theme (Sobur, 2002). One of the films that are educational and full of meaning is the film "Joe Bell". This film represents the meaning that bullying is an act that is not justified and something that must be prevented. Representation produces meaning by connecting signs, language, and culture that represent something (Hall, 1997). In this film, the thing that stands out and is represented is bullying. Bullying is a social phenomenon that occurs in society in the form of verbal, physical, or psychological abuse towards other people who are felt to be weaker and aim to hurt which is carried out continuously without mercy (Kartika, Darmayanti and Kurniawati, 2019).

There are several studies previously researched about the representation of bullying in movies. However, researchers refer to research previously entitled "Representation of The Values Bullying in The Doraemon Cartoon Series". The method used in the study earlier studies qualitative with data collection through observation and observation in a manner thorough to object research. Difference study previously a study that is lies on focus discussion as well as classification results of the data. The study previously emphasizes expression and action from figures universally or whole. Whereas study this based on the kind of bullying of Coloroso (2007). Besides

it, the object from the study previously used cartoon/fiction series in Japan, not a non-fiction/documentary film as in research.

Study this aim to know signs from *bullying* in the movie "Joe Bell" through the data collected based on draft types *bullying* from Coloraso. Researcher will use method study qualitative descriptive and theoretical semiotics Roland Barthes in analyze the data.

2. Method

This research method uses qualitative research methods and is descriptive. The data collection technique consists of documentation consisting of the film "Joe Bell" and literature studies. The entire data obtained will then be analyzed using a related theory, namely Roland Barthes' semiotics. In this qualitative research, the researcher becomes the main instrument (key instrument) with special characteristics or advantages (Syahrum, 2012).

Roland Barthes developed 2 levels of semiotics, namely denotation, and connotation. The denotation sign is formed from markers and signs. The denotation sign is the same as the connotation marker. Meanwhile, the connotative sign consists of a marker and a connotative sign. Denotation is the first level or true meaning that is formed based on the human senses. The definition of denotation has a clear, fixed, and real meaning. The second level is connotative which has the same position as the implicit meaning which is uncertain and is formed based on psychology, feelings, and beliefs (Adawiyah, 2019). Meanwhile, myth according to Roland Barthes plays on the second level of signification or the level of language connotation. According to him, the connotation is a denotation of something that he considers to be a myth, and myth has connotations for certain ideologies (Barthes, 1991).

The validity of the data uses source triangulation, namely a combination of primary and secondary data. The type of data used is primary data, namely the film "Joe Bell" which was watched via the Netflix platform. Secondary data sources in the form of literature, books, and previous journals refer to this research. Some of this literature, books, and journals come from local / Indonesian and international research.

3. Result and Discussion

Based on the researcher's observations using Roland Barthes' semiotic theory, the researcher found signs of bullying issues in the movie "Joe Bell" with the main object experienced by the victim, namely Jadin. The researcher found several scenes with classifications based on the type of bullying from Coloraso, namely verbal bullying, physical bullying, and cyberbullying. The data that has been collected is then analyzed based on the method used in this study.

1) Verbal bullying in minutes 00:18:24

Frequent verbal bullying happens in this movie makes the type of bullying develop Become bullying in a manner physical. Bullying in a manner physical scene could be seen from some people in sight currently pulling, lifting, pushing, up harassing Jadin. From this physical bullying, it can be seen that the perpetrators do not feel guilty even outside the school the perpetrators continue to bully digitally through social media. The perpetrator was seen making fun of Jadin with a very painful typing like the word "faggot" which was very frontal.

Based on the data collected researchers use the theory of Roland Barthes' semiotics exists meaning connotation, denotation, as well myth in the related "Joe Bell" movie issue of bullying. Some scenes show that behavior Bullying often occurs in the school environment. Begin with insults and harsh words, encouragement, pulling, to social media. The bullying victim named Jadin always gets this behavior when he is at school. Victims of bullying usually have psychological pressure that makes it difficult for them to be accepted by their peers. This bullying most often occurs in schools because the scope is small and everyone or students are included in it. Every student has different characteristics and backgrounds so this act of bullying very often occurs in schools (Widianti, 2019).

A school is a place for children to form character education, socialize, and increase children's creativity. Character education must be implemented in schools so that students have a character that is by existing norms or norms. Teachers are expected to be able to educate and shape the character of students to become students who excel, are kind to others, honest, and responsible (Saleh, 2022). The cultivation of this character value must be done as early as possible. Students are also expected to be able to communicate healthily and maintain good relationships with peers or other students (Ballerina & Immanuel, 2019). The forms of bullying Jadin experienced included verbal bullying, physical bullying, and cyberbullying.

Verbal bullying is an act of oppression using verbal or words that can take the form of insults, insults, slander, hate speech, criticism that drops, makes nicknames (name calling), and words with a curse (Pratiwi, Herlina and Utami, 2021). Scene 1 at minute 00:18:24 shows Jadin experiencing bullying with harsh words, name-calling, insults, and utterances of hatred accompanied by loud tones and screams. The myth that is someone brave says harsh words to somebody who has a sense of power. Bullying verbally that occurs continuously will develop into physical bullying.

Bullying in a manner physical (Physical bullying) is something shape bullying to somebody with action real and visible. Shape from Physical bullying among others kicking, pinching, pushing, and being hit (Arif & Novrianda, 2019). Scene 2 at minute 00:55:10 shows Jadin as forced and groaning in pain because the perpetrator is doing physical bullying in an unexpected and coercive way. The myth that is action often takes place in a quiet, dark, and closed place like school toilets. Beside that's the culprit bullying that isn't satisfied with what is he do in a manner direct, then will do bullying no live or far. One of them through the usual virtual or digital world called with cyberbullying.

According to Hinduja and Patchin (2008), Cyberbullying is something action bullying that with on purpose harm others through electronic media or with technology communication. Cyberbullying this could form deployment speech hatred, create news fake (hoax), slander, up to post shame someone (Sameer Hinduja, 2008). Scene 3 at minute 00:57:19 shows Jadin receiving messages from the perpetrator's account named La Grande with harsh typing words, swearing, and painful jokes. The myth that is actions performed in cyberspace will impact in a manner real as bother mental health.

Of the several forms of bullying found in the film "Joe Bell", of course, there are also impacts resulting from bullying. Bullying is very influential on mental health, especially for the victim and the victim's family. Starting from deep sadness, and depression, to causing suicide (Munawarah, 2022). Victims of bullying also have difficulty controlling their emotions in the face of a failure or mistake. If this is not prevented early on, it can be fatal in the future and even suicide due to being unable to withstand the pain (Zakiyah et al., 2019).

This happens due to several factors. One of them is a person's character. Characteristics of a person are usually the trigger for the emergence of bullying. Start from the physical, character, accent, to personality. It is the characteristics of the perpetrator and the victim that have differences that lead to bullying. Usually, the perpetrators of bullying have characteristics that dominate or are the majority in that environment, while the victims have different characteristics or are a minority in that environment (Sari & Azwar, 2018).

In overcoming deviant behavior such as bullying, cooperation between the school and other related parties, such as parents, must be carried out. Parents and teachers must be able to work together to instill character education. They must be able to educate their children well and inform them that bullying is a negative action because it harms other people. One of the efforts to stop bullying is to give children an understanding of the impact of bullying, what if it happens to those closest to them, tell children how to ask for help if they experience bullying, and tell children to be more open (Oktavia & Dewi, 2021).
